Terms and Conditions

1. Payment:
 The full amount for a camp due to LIQUID GRACE must be paid by no later than Two (2) weeks prior to the start of a camp. If this is not done LIQUID GRACE may regard the booking as cancelled by the Client.
2. Cancellations by the client:
 No cancellation will be deemed effective if not received by LIQUID GRACE in writing. If the cancellation is received 14 days or more prior to the commencement of a camp, then the full deposit will be forfeited. If the cancellation is received within 14 days or less of the commencement of a camp, the following charges will apply
 - 14 to 7 days – 50% of the total costs
 - 7 to 0 days – 75% of the total costs
3. Cancellations by the company:
 LIQUID GRACE reserves the right to cancel a camp, in any circumstances, and all camps shall operate subject to a minimum number of participants per camp. In the instance where LIQUID GRACE cannot provide the camp booked, then LIQUID GRACE will return to the client all monies paid, which shall constitute the full extent of LIQUID GRACE'S liability to the client, or LIQUID GRACE may offer the client an alternative camp of comparable standard.
4. Alterations:
 No employee or representative of LIQUID GRACE has the right neither to alter, vary, waive the right of these conditions, nor to undertake any liability whatsoever on behalf of LIQUID GRACE, unless such be in writing and signed by the members of LIQUID GRACE ADVENTURES CC.

5. **Baggage:**
All personal property, baggage and personal effects are at all times at the participants own risk and LIQUID GRACE cannot accept liability for any loss or damage to personal property, baggage or personal effects.
6. **Information:**
Information given in the brochures, leaflets, and advertising is given in good faith by LIQUID GRACE and these are based on the latest information at the time of publication. While every endeavour is made to keep to the prices for camps, LIQUID GRACE reserves the right to increase costs at any time due to unforeseen increases to which it may be subjected.
7. **Photographic material:**
Participants should be aware that the staff and representatives of LIQUID GRACE may take photographs and films of the participant while on any camp, and LIQUID GRACE reserves the right to use such material for any advertising, brochure or publication without obtaining consent or payment to the participant.
8. **Jurisdictions and Law:**
This application is subject to the jurisdiction of the courts of the Republic of South Africa and shall be interpreted under the laws of the Republic of South Africa.
9. **Severability:**
If any part, term or provision of this application is held to be illegal or unenforceable, it shall not affect the validity of enforceability of the remainder of the application. Furthermore, if any covenants are held illegal or unforeseeable by virtue of its scale, extent or duration, it shall remain valid and enforceable in such reduced scale, extent or duration as any court may decide as being the maximum scale, extent or duration permissible.

Rules and Regulations

Rules include but are in no way limited to the following:

1. No person may participate in any activities unless they have signed a **PARTICIPANT'S WAIVER, RELEASE OF LIABILITY & ACKNOWLEDGMENT OF RISK AGREEMENT** and a copy of the signed agreement is on file with LIQUID GRACE.
2. Participants must wear full protective and safety gear for each activity as instructed by any staff member of LIQUID GRACE.
3. Participants must engage in all activities in a safe manner at all times and avoid collision with other persons and/or property.
4. Participants must obey the safety instructions of LIQUID GRACE staff at all times.
5. Smoking is prohibited.
6. Alcohol and illegal drugs are prohibited.
7. No profanity or vulgar language is permitted.
8. No weapons are allowed.
9. Participants must obey all posted rules.
10. Participants will be ejected from a camp with immediate effect and without refund for any of the following reasons:
 - a. Fighting or other aggressive or disruptive behavior.
 - b. Using or being in possession of alcohol.
 - c. Using or being in possession of illegal drugs.
 - d. Being in possession of any weapons.
11. LIQUID GRACE reserves the right to terminate and eject anyone from a camp at any time for any reason deemed necessary without refund.
12. Violations of rules may result in ejection from and cancellation of a camp without refund.
